What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include:

	When you are <b>no longer</b> our customer, we continue to share your information as described in this memorandum.
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information; the reasons choose to share; and whether you can limit this sharing.

Joint marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you.
